# Transparency notification by Norges Bank

In accordance with article 14, § 1 of the law of 2 May 2007 on disclosure of major holdings Norges Bank has recently notified Umicore that it has crossed the statutory threshold of 5% for the total of direct voting rights + equivalent financial instruments.
