# Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on disclosure of major holdings, BlackRock Inc. has recently notified Umicore that it has consecutively crossed the legal threshold of 5% for the direct voting rights: upwards on August 9<sup>th</sup> 2023 and then downwards on August 10<sup>th</sup> 2023.

The total holding of direct voting rights and equivalent financial instruments stands now at 5.67%.
