Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on disclosure of major holdings, BlackRock Inc. has recently notified Umicore that it has consecutively crossed the legal threshold of 5% for the direct voting rights: upwards on October 26th 2023 and then downwards on October 27th 2023 and then again upwards on October 31st.

The total holding of direct voting rights and equivalent financial instruments stands now at 5.53%.
