Transparency notifications by Bank of America Corporation

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by Bank of America Corporation that:

- Bank of America Corporation has crossed the legal threshold of 3% for the equivalent financial instruments downwards on 11 December 2025.
- Its subsidiary Merrill Lynch International has crossed the legal threshold of 3% for the direct voting rights and equivalent financial instruments upwards on 11 December 2025.
- Bank of America Corporation has crossed the legal threshold of 3% for the equivalent financial instruments upwards on 12 December 2025.

The total holding of direct voting rights and equivalent financial instruments of Bank of America Corporation stands at 3.66% on 12 December 2025.
