

Transparency notifications by Amundi SA

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by Amundi SA that it has successively crossed the legal threshold of 3% for the direct voting rights instruments upwards on 30 January 2026 and then downwards on 3 February 2026.

The total holding of direct voting rights and equivalent financial instruments of Amundi SA stands at 2.27% on 3 February 2026.
