

## Transparency notification by BNP Paribas Asset Management SA

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BNP Paribas Asset Management SA that it has crossed the legal threshold of 3% for the direct voting rights upwards on 5 February 2026.

The total holding of direct voting rights and equivalent financial instruments of BNP Paribas Asset Management SA stands at 3.08% on 5 February 2026.
