

Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BlackRock, Inc. that it has crossed the legal threshold of 5% for the direct voting rights downwards on 8 April 2026 and then upwards on 9 April 2026.

The total holding of direct voting rights and equivalent financial instruments of BlackRock, Inc. stands at 5.69% on 9 April 2026.
