

## Transparency notification by JP Morgan Asset Management Holdings Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by JP Morgan Asset Management Holdings Inc. that it has crossed the legal threshold of 3% for the direct voting rights and equivalent financial instruments downwards on 27 April 2026.

The total holding of direct voting rights and equivalent financial instruments of JP Morgan Asset Management Holdings Inc. stands at 2.90% on 27 April 2026.
