

## Transparency notification by BNP Paribas Asset Management Holding and BNP Paribas Cardif

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BNP Paribas Asset Management Holding and BNP Paribas Cardif that it has crossed the legal threshold of 3% for the direct voting rights upwards on 27 May 2026.

The total holding of direct voting rights and equivalent financial instruments of BNP Paribas Asset Management Holding and BNP Paribas Cardif stands at 3.05% on 27 May 2026.
