

Transparency notification by BNP Paribas Asset Management Holding and BNP Paribas Cardif

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BNP Paribas Asset Management Holding and BNP Paribas Cardif that it has crossed the legal threshold of 3% for the direct voting rights downwards on 2 July 2026.

The total holding of direct voting rights and equivalent financial instruments of BNP Paribas Asset Management Holding and BNP Paribas Cardif stands at 2.88% on 2 July 2026.
